

WE FOUGHT CITY HALL - AND WON-

In September 1988, it was written on the front page of the Reporter: "IT'S ALL A BIG LIE! HIGHLAND PARK IS STILL ALIVE! IT IS NOT A DONE DEAL1 ORGANIZE1 THERE IS STILL TIME1" That headline proved to be true. On October 19, 1990, the Kentucky Supreme Court ruled the Urban Renewal Project affecting Highland Park, Prestonia, and Standiford as being unconstitutional. It was all a big lie, it was not a done deal, and Highland Park is still alive! We organized! We fought! We won! We have been victorious. Yet, many wonder what we have won. I have heard mixed feelings during the past week. Most are joyous. Some people are Worried. Some residents want to move back and rebuild Highland Park. Some residents still want to move. At this time, it is important

to understand that even though we have won, we are still unclear as to the meaning. Both the City and neighborhood's attorneys have ten days to respond to the Court. At that point, we will all know which direction we are going.

I urge each of you to be respectful of each resident's opinions. Some residents who haven moved are mad at the

never moved are mad at the ones who did move. Some who had resolved to move are now in limbo. Please remember the answer to your problems are soon to be had. We all need to continue to be supportive of each other and of the HPNA. Most persons are forgetting one important aspect of our victory. We, the people, are now in the drivers seat. City only wanted our land. They do not have the right to force you out. If you are patient, maybe you will fare better financially. Maybe you could sell to whomever you choose at your price. Or stay in your home.

If you moved out of fear or stress and want to return to Highland Park, maybe you can get your wish. The City took properties illegally under the guise of Urban Renewal.

Undoubtedly, many lawsuits will be filed. Without a doubt, we have been treated ruthlessly and illegally. No matter how one may feel about their personal problems arising from the Urban Renewal project, remember those of our residents who succumbed to the stress and cannot be with us to celebrate in our moment of happiness and victory.

I urge as many of you as possible to attend the next HPNA meeting. Be calm, be patient, and relax. You may not feel it, but you once again have control of your life, your home, your business. Use it to your advantage. Make the next meeting and share your viewpoints.

We all have lived through twenty-eight months of hell. We all will survive a little longer. The pressure is off for now. Highland Park has been a part of history. The Supreme Court decision will be printed in law books to assist others from ever going through the same land grab we are experiencing. This is a great contribution.

Highland Park is alive and well! Celebrating our 100th year. We fought City Hall and - WON!







TROXLE FAMILY 434 Wenona


